For booked Team's rooms not used, the Organizer is allowed to claim a cancellation fee from the National Ski Associations (FIS rules).

The price for the daily full board accommodation, for those over national quotas, is:

### Transportation:

If necessary and required the transport from Prague Airport Ruzyně to Liberec and return will be provided by the Organising Committee.

Shuttle transport will be available from the Hotel Babylon to the competition areas according to the competition schedule.

### DEADLINE:

**Deadline for the Entry and accommodation/transport request form is 7<sup>th</sup> February 2012.**

For Entries and forms arriving later than the deadline, the Organizing Committee can't guarantee smooth travel and accommodation arrangements for the Teams.

### Economy and payment:

Financial conditions are according to the FIS rules and regulations. The Organising Committee will pay for the full board accommodation and travel costs according to the FIS Nordic Combined national quota.

The reimbursement of travel expenses will be paid in cash.  
The prize money will be paid to bank accounts.

The payment of costs for persons **over** national quota will be possible only in **CASH!!!**

### Insurance:

All athletes have to be insured by their own National Ski Associations. The Organizer has coverage for their own third part liability only. All participants have to be covered by an adequate insurance policy against accidents, illness and civil liability.

### Doping Control:

Doping control may be carried out at any FIS competition according to FIS Anti-Doping Rules.

### Radio Stations

The Czech Republic allows free communication channels for PMR devices on all channels the PMR can tune.

It is permitted to use free channels on analogue professional devices on reserved frequencies with the following parameters:

frequency	Max. output	Bandwidth
172,650; 172,950; 172,975 MHz	5W e.r.p.	10kHz
172,725; 173,050 MHz	1W e.r.p.	10kHz
448,490; 448,570; 448,610 MHz	5W e.r.p.	14kHz
449,770; 449,810 MHz	1W e.r.p.	14kHz

The above mentioned free channels have no jamming protection from other users or other services operating on radio frequencies.

The Organising Committee offers reserved paid channels that can be used for communication. These must be booked with the OC. The fee for using a channel of 10 and 14 kHz bandwidth respectively during the competitions is 30 €. These reserved channels will not be jammed by other users upholding the laws of the Czech Republic.
